

Minutes of the Town Council meeting held on Monday 6th November 2023 at 6.30pm in the Cleobury Country Centre, Cleobury Mortimer.

Present:

The Chair, Cllr John Greaves welcomed everyone to the November meeting.

11.01.23 Apologies for absence.

Cllr Phil Clarke – work Cllr Ken Walsh – unwell Unitary Cllrs Gwilym Butler and Simon Harris.

11.02.23 Declaration of interests.

Cllr Buck declared an interest in all Agenda items under 11.07.23 relating to the Food Bank.

11.03.23 Public Participation Session.

There were eight members of public present. Points raised from the public session:

- Residents from Pinkham raised concerns about flooding of their properties during Storm Babet and asked for Council support with Shropshire Council, the Environment Agency and Severn Trent. There was flooding from the river but also from the ground above the houses which washed out the footpath as well as surface water from the access road. There was also a sewage breach upstream. Residents asked if the river could be widened to reduce water levels. The Town Council will contact the authorities and ask for them to liaise with the residents and look at solutions to reduce the impact of heavy rainfall. Residents are encouraged to keep reporting issues with the roads to Shropshire Council via Fix My Street. It is recognised that Storm Babet has made existing issues worse and that blocked drains through the town do not direct water away from properties. Many drains have still not been cleaned out since the flooding issues in the summer despite assurances from Shropshire Council that they will all be cleared. Local streams flooded minor roads and there is concern that any new development needs a much larger-capacity surface water management system. Most surface water currently goes into the sewerage treatment plant which will not be permitted with any new developments. Severn Trent will be asked how their proposed new treatment plant will cope with such storms in the future and for assurances that there will be no further similar breaches.
- > Other residents raised concerns about the road drains not working correctly and the amount of debris and trees which came down the river in the recent storm causing damage to bridges and river banks.
- ➤ There is a damaged sign at Pinkham a replacement has been ordered.
- The boundary hedge to the rear of the Nursing Home site has still not been attended to. The Clerk will write to the landowner and request the hedge is cut back and preferably pleached.
- Mr Smith, Tree Warden is aware of the Neighbourhood Development Plan Referendum and asked where people can find more information about it. Information is available in the Library and online.
- Mr Smith raised concerns that planning applications are being validated without the full information required. A current application for tree works has no sketch map provided which makes it difficult to assess the proposals in the application.

11.04.23 Minutes of the Town Council Meeting held on Monday 2nd October 2023.
