Minutes of the ORDINARY MEETING of the CLEOBURY MORTIMER PARISH COUNCIL held at the Market Hall on Monday 5th January 2009 at 7.30pm.

PRESENT Cllr K. Reynolds (Chairman), Cllrs Mrs B. Davies, Mrs D. Brown, & Messrs G. Carter, J. Griffiths & M. Reiner.

0 members of the Public were present.

1.1 APOLOGIES FOR ABSENCE.

Clir Mrs R. Lloyd (Prior engagement) Clir G. Butler (Feeling unwell)

The **Chairman** wished everyone a Happy New Year and read out a letter he had received from **Cllr C Genese** saying that due to increased work commitments he was submitting his resignation to take effect immediately. **Cllr Mrs B. Davies** said this Council should write to **Cllr Genese** and thank him for his input over the last two years. The Clerk was asked to contact Trudy Gough. Electoral Officer, South Shropshire District Council and inform her of the situation.

1.2 DECLARATION OF INTERESTS.

Clir G. Carter declared a Prejudicial Interest in Agenda items 1.7 (a), (b) & (f) Clir Mrs B. Davies declared a Personal Interest in Agenda items 1.8.23 Clir M. Reiner declared a Personal Interest in Agenda items 1.7 (e)

1.3 TO ADOPT THE MINUTES OF THE MEETING HELD ON THE 1ST DECEMBER 2008

CIIr M. Reiner said the minute about the flooding at New Bridge should read Mr Phil James not Phil Jones.

It was proposed by **CIIr G. Carter** and seconded by **CIIr Mrs D. Brown** that the minutes, with the above correction, be adopted as a true record **RESOLVED** (All in favour)

1.4 MATTERS ARISING FROM THE MINUTES

There were no matters arising from the minutes.

1.5. PARISH MATTERS.

- 1.5.1 **CIIr M. Reiner** said the hedge in Childe Road hadn't been cut. **CIIr G. Carter** said the state the hedge was in was caused by a certain lady hacking the hedge. **CIIr Mrs B. Davies** said she was seeing Glyn Shaw, Shropshire County Council about their promise to erect signs to stop large lorries trying to go down the narrow part of Childe Road and she would mention the problem with the hedge.
- 1.5.2 **CIIr M. Reiner** said he had reported that he had met Phil James, Shropshire County Council about the flooding at New Bridge but there had been no improvement. He said the New Bridge was flooded again on the 30th December and all they did was to put up Flood Warning signs. The Clerk was asked to write to the County Council.

1.5. PARISH MATTERS (CONTINUED).

- 1.5.3 **Clir Mrs D. Brown** said she had received comments about vehicles being parked on the pavement just above the Bell Inn. The **Chairman** said this problem has been going on for years and he suggested that the matter be raised at the meeting next month when PC Sarah Payne hoped to attend.
- 1.5.4 **Clir Mrs D. Brown** said the gritting from Cleobury Mortimer to the Horse and Jockey had been much better this year but Worcester County Council had not been gritting from the county border to the A456. The Clerk said he would write to the authorities. The **Chairman** said Love Lane through to Langlands Road & Ronhill had been very slippery and the conditions were that bad that a 4-wheeled drive vehicle had gone through a hedge by the Primary School. **Clir Mrs B. Davies** said we have tried to get the school routes gritted but the County Council say it's not in their remit.
- 1.5.5 **CIIr J. Griffiths** said the 20/30MPH signs just to the east of Hems, High Street are too close to the pavement. He had a wing mirror on a large vehicle hit the sign the other day resulting in a bill of £300. **CIIr J. Griffiths** said the road is very narrow at this point. **CIIr Mrs B. Davies** agreed and said there are often hold ups at this point and suggested we raise this matter with Glyn Shaw, Shropshire County Council.
- 1.5.6 **Clir G. Carter** said the Salt Bin at the Lea View/Catherton Road junction had been removed. The Clerk was asked to inform Shropshire County Councils' Highway Department.
- 1.5.7 **Clir G. Carter** said there had been further flooding at Cleobury Mill and asked if the Parish Council had managed to get any sand bags. The **Chairman** said **Clir G. Butler** said he would look into the possibility of getting a supply of sand bags. The members debated where they could store sand.
- 1.5.8 **CIIr Mrs B. Davies** said she had received complaints about the mole hills in the Cemetery. She said Mr A. Mantle had told her that Mr D Bowen had placed an advert in Cleobury News offering his service for catching moles. The **Chairman** said he would get the details from Mr Mantle.
- 1.5.9 **CIIr Mrs B. Davies** said there was a proliferation of rats around the Electric Substation in the Hurst. The Clerk was asked to notify Mr Steve Price, Environment Department, South Shropshire District Council.
- 1.5.10 The **Chairman** said the following streetlights were out at the following places (1) outside 40 Furlongs Road (2) Three in Lea View (3) One outside Mr M Chopin's house in Catherton Road.. The Clerk said there have been problems with the light in Catherton Road and agenda items 1.6.19 &1.6.20 deal with this matter. He said Natalie Owen, Prysmian says they have been out and reset the clock again, due to a faulty calendar. Their electrician suggests a new lantern and rewire if this happens again, however the Parish Council will need to specify what type of lantern we require i.e. should it match the other streetlights in Catherton Road.
- 1.5.11 The **Chairman** said he was concerned about the number of businesses that have closed and he felt they were entitled to compensation. **CIIr J. Griffiths** said Severn Trent paid compensation when businesses were disrupted. **CIIr Mrs B. Davies** said it was up to the Chamber of Trade to seek compensation. **CIIr J. Griffiths** said it appears to be a Chamber of non-traders. **CIIr Mrs B. Davies** said it is not within the Parish Councils remit.

1.5. PARISH MATTERS (CONTINUED).

- 1.5.12 The **Chairman** said when he and **Clir Mrs D. Brown** walked around the town to consider the location of the benches they agreed that the railings at the A4117 side of the Cemetery needed painting. He said he would get quotes and submit them at the February meeting.
- 1.5.13 **CIIr M. Reiner** said the benches at Lower Inhedge and the Cemetery did not have concrete bases and the legs would become rotten very quickly. **CIIr G. Carter** said he would look at them and report back to this Council.

He said more meetings were being arranged in various locations in South Shropshire and he suggested that now the Council was in a better financial position they should pay something towards the costs incurred. It was proposed by Clir K Reynolds and seconded by Clir G. Carter that this Council pay 40 pence per mile. RESOLVED (All in favour)

1.10 FINALISING THE PRECEPT FOR 2009-2010

The members reviewed the draft Precept that they had set at the last meeting and made some alterations. It was proposed by **Clir M. Reiner** and seconded by **Clir Mrs D. Brown** that the final amount for 2009/2010 should be set at £40,030 **RESOLVED** (All in favour).
