Minutes of the Cleobury Mortimer Parish Council held at the Market Hall on Monday 6th June 2011 at 6.00 p.m.

Cllr S Thorogood welcomed everyone to the meeting of the Parish Council and asked if any of the Public present would like to speak for the first 15 minutes. Taking into account that questions may be asked and noted for a reply at a later time if not given straight away.

Mrs Griffiths said that the acoustics in the hall was terrible.

The Chairman Cllr S Thorogood said that it was being looked at by the Market Hall Committee, as the Parish Council meetings were always downstairs and now we are seeking to encourage more public interest it will always be upstairs.

Mrs Griffiths said that there was poor communication about the Medical Centre and was disturbed that those in authority were not acting with integrity. We have been down this road before with the Market Hall and they did not communicate with the Public and it all went wrong with the bulletin but Don Griffiths saved the town from humiliation taking the reigns' and the Clarion was a propaganda magazine. The Public have been misled and disgruntled by Gwilym and the Cleobury Newsletter.

Cllr S Thorogood said that it is her opinion as everyone has a right to have, but have not had any other comments to that effect.

The Clerk said that the Parish Council are being as open as allowed within the legal restraints set down in law. We are more open with a website and notices on the Notice board and also a Bulletin is in the process of being done. Also because he should be taking time off, having just buried his Uncle and Father a few days earlier, the importance of the Medical Centre issues among others, people need to know and things need to be kept up to date, so need to keep working.

Cllr S Thorogood explained that what is being done is open book and a lot of what was below the line is not any more.

Cllr B Davies said that Shropshire Council can do things.

Cllr G Butler said that the council had been in touch with the owner and has tried to change covenant from Nursing to residential but the Bank wants 30% up front which he does not have. Perhaps it should be an Agenda item for next meeting.

Cllr G Hainsworth asked what was happening with the CCTV.

Cllr G Butler said that he would have more information for the next meeting.

Clerk noted for July Agenda.

Cllr G Hainsworth said that the street had been re surfaced but there were holes in places where it did not stick.

Cllr G Butler proposed that the payments are correct and to be paid, seconded by Cllr G Hainsworth. Voted all in favour.**RESOLVED.**

06.8 Medical Centre Update (Cllr G Butler)

Cllr G Butler said that we need to set up a working group, not to make any decisions, but to bring back to the Parish Council. We need to agree abnormal costs that Matrix gets a Quantity Surveyor plus they are talking about further abnormal costs like a crossing. Cllr J Griffiths said that Matrix have had long enough.

Cllr G Butler said that Bovis do not want to do a deal with the Jag site and because Cllr Reynolds proposed, voted and resolved their offer; it cannot be looked at again for six months.

Cllr J Griffiths said what about Blue Square?

Cllr G Butler said they have not made an offer yet and we stand to lose one million pounds of funding.

Also he has heard that the land that has not been sold to Blue Square is not happy with rumours. Also I need to say that that Matrix have offered the £170,000 less abnormal costs, we should give them until 30th June to get the abnormal costs.

Cllr B Davies and Cllr J Griffiths said that we seem to be going around in circles.

Cllr G Butler said we need to give 14 days' notice for a public meeting.

Cllr S Thorogood said Matrix has tried to push us into a corner to sign things and the worst case could actually be a cost to us. We don't want to lose the PCT funding, but it needs to go to a public meeting.

Cllr B Davies said that if was going to cost us then other parishes that benefit should also be involved.

Meeting 6th June Cont.

Cllr G Butler said that in March this parish council agreed to provide a site on the Vaughan road site.

Cllr M Reiner said we should accept the best offer.

Cllr G Butler said we could lose one million pounds from the PCT.

It was then discussed to get a working group together to meet with Matrix to move things on.

Cllr G Hainsworth proposed all of the parish councillors if available to have a meeting 15th June 2011 3pm with our solicitor and 4pm with Matrix. This was seconded by Cllr B Davies. Voted all in favour. **RESOLVED.**

Cllr G Butler said he would see if he could get the surveyor from Shropshire Council to attend

Cllr D Brown asked that the Clerk inform her as soon as possible when organised.

Cllr J Griffiths asked what the deadline on the PCT funding was.

Cllr G Butler said he was not sure but there is always a chance it could be withdrawn.

Cllr G Butler asked the Clerk to find out about voting by proxy in case a councillor cannot make a meeting.

Noted by the Clerk.

06.9 Cemetery Issues (Cllr M Reiner, Clerk)

The Clerk explained that the Cemetery path was done and was a very good job which has raised a lot of good comments. But it still needed a lot of work to make it a nice place to sit. He visits his mother's grave in Worcester and it is such a nice peaceful place to sit, which is very well kept. Also he had received a letter from a neighbour that had a branch fall in his garden.

After looking around the Cemetery there was a large tree that needs capping and a lot of trees need a good tidying up. Also the path needs finishing off now the other side and we need to be thinking way ahead by trying to expand the cemetery.

Cllr G Butler said that planning may be required for the big tree.

Cllr D Brown said that she had gone to look for graves with relatives and the new path made it look very respectful. But the unkept grave lets it down. She said her dad is a volunteer who cuts unkept graves and perhaps we could start something like that here.

Cllr G Butler said maybe the youth group or Horticultural society could be approached.

Cllr G Butler said perhaps we could have a working group to be put on the next meeting Agenda.

06.10 Parish Hall Caretaker (Cllr S Thorogood)

Cllr S Thorogood said that we need to help if we can but we would need a proposal from the Parish Hall.

Cllr B Davies said the Parish Hall always run on its own, there has been a lot of chairman's and have always had to work hard to make it pay. Old buildings always require work also the cottages.

Clir G Butler said we could possibly get a caretaker to cover both the Market Hall and Parish Hall and could manage both as one.

Cllr S Thorogood said that is only if the Market Hall caretaker agrees.

Cllr G Butler proposed suspending the meeting to allow the chairman of the Parish Hall to speak, seconded by Cllr D Brown. Voted all in favour. **RESOLVED.**

Mr Griffiths said that the Parish Hall needed a separate caretaker. In the last 8 years his wife has raised a six figure sum for the Hall. He then went through a list of duties required for the hall. We just paid £350 for a week to have things done.

Cllr G Butler asked how many hours a week would be required.

<u>Meeting 6th June Cont.</u>Mr Griffiths said the caretaker would have to be two days a week and if the person was shared the Parish hall would need first call. He said he wanted to finish in the autumn, we have a small committee who work hard but it is not enough, we need a caretaker.

Cllr B Davies said that one of the cottages was always a caretaker's cottage.

Cllr D Brown asked if both cottages were occupied.

Mr G Carter said that the money collected is always ploughed back in.

Cllr G Butler asked that if we paid half would the Parish Hall pay half.

Mr Carter mentioned PAYE and contracts.

Cllr G Butler suggested putting a proposal together to put to the parish council at the next meeting.

Mr Griffiths said he would get it done.

Cllr S Thorogood proposed moving back to the meeting. Seconded by Cllr G Hainsworth. Voted all in favour. **RESOLVED.**

06.11 Accounts (Clerk)

The Clerk explained that the accounts were away with the internal auditor being checked but when completed they needed agreeing by the parish council before sending off to the external auditor.

Cllr G Butler proposed a sub committee consisting of Cllr S Thorogood, Cllr G Hainsworth and Cllr D Brown, seconded by Cllr B Davies. Voted all in favour. **RESOLVED.**
