## 0.10.9 Lime Trees (Cllr S Thorogood)

**Clir S Thorogood** read out the following e-mail received.

#### **Lime trees – High Street, Cleobury Mortimer**

I am grateful to Matt Sheehan for agreeing to include discussion of the lime tree pleaching on the agenda for the Parish Council's meeting on Monday 3 October. I thought it might be useful to set out relevant information and the decisions that now need to be made if the work is to be taken forward.

#### **Current situation**

• Lewis Arborcare Limited undertook the pleaching last year at a net cost of £2750. The company has given the same quote for the current year (see attachments) although it may be

possible to reduce it by approximately £400 should no re-tensioning or renewal of the supporting guy ropes prove necessary.

- Shropshire Council is content with this quote rather than going through a tendering process: it considers the amount of expenditure to be minor (below £10,000) and the exercise two years ago gave a cheaper paper quote but an inferior outcome. Kate Adams, Street Scene Manager (south-west) states that the Council's view is that Lewis Arborcare Limited is 'efficient, works to a high standard and organises all health and safety aspects thoroughly.' As you know well, pleaching does not equate to pruning; it is a specialised process and it is evident from last year's outcome that Lewis Arborcare Limited is able to carry it out knowledgeably, expertly and safely, delivering very good value for money.
- In his letter that was copied to the Parish Council on 2 September 2011, Steve Brown (Head of Environmental Maintenance, Shropshire Council) agreed to pay half the cost of pleaching the lime trees, which will be in the region of £1,325.
- From a letter I sent to you on 6 September 2011, you will be aware that members of the local community have committed to contribute £350 annually towards the cost of the pleaching. This reduces significantly the amount the Parish Council would need to contribute, which would therefore be in the region of £975 net.
- Cleobury Mortimer Horticultural Society would like to purchase a plaque to indicate that the trees were planted to commemorate Queen Victoria's Diamond Jubilee in 1896. Shropshire Council has indicated it is content with this if the plaque is set into the pavement or the brick edging that surrounds the tree beds. The Society would pay for the plaque and its installation, which would be carried out by Shropshire Council's landscaping operatives.

#### **Decisions needed:**

- 1. Is the Parish Council content with the quote from Lewis Arborcare Limited?
- 2. Is the Parish Council willing to contribute the amount necessary for the pleaching to take place this year?
- 3. Is the Parish Council content for a suitable plaque to be purchased and installed at no cost?

0.10.11 The Queen's Diamond Jubilee Beacons (Cllr S Thorogood)

**Clir S Thorogood** explained that the idea was to place beacons on high ground throughout the country to be lit in a line of sight.

It was agreed that Cllr D Brown would see what the LJC was planning first and bring back to the Parish Council.
