- 1) Meeting with Parish Hall and Market Hall Trustees has now taken place.
- 2) The Plans for the Parking Review has now been received.
- 3) Historic Core Project has now held its meeting with the Church.
- 4) A meeting with the Primary School has now taken place. See att Agenda. One point about the danger to children has been addressed already, as new signs will be put up and SLOW

will be painted on the road both ends. Dog fouling is being dealt with Heidi Steel and the School field upkeep is being looked into by the clerk.

- b. Light requested for Curdale Close, also a Cul-de-sac sign.
- c. Problem with Bus drivers either not picking up or not being polite to passengers. Have met senior manager at FIRST depot in Kidderminster and it is in hand. We need a meeting in the future to firmly identify and mark all bus stops.
- d. I am still waiting for the plans for the new toilets. Will chase again.

Cllr G Butler raised the point of New Toilets and to chase up plans.

Cllr G Hainsworth reported that after a meeting with Highways we are to have new LED High Visibility lights fitted on the Zebra Crossing.

A Pelican crossing would cost £40,000.

Cllr G Butler reported that our new street cleaner is Mr Wayne Speak long term.
