Minutes of extraordinary Parish Council meeting held on MONDAY 22nd JUNE 2015, at 7.30pm in the Market Hall, Cleobury Mortimer.

15.06E.0 Democratic 15 minute Public Time

Cllr Thorogood welcomed everyone to the meeting and invited members of the public to speak. Mr Paul Baldwin raised concerns about the planning applications for the rear of 4 Church Street (Ref 15/01976/FUL and 15/01977/LBC). Mr Baldwin handed out photographs of the communal area and indicated the height of the proposed entrance lobby. He felt the plans submitted were inaccurate as the doors and windows on his property were omitted.

Mr Tony Smith said the Planning Officer was aware of telephone and IT issues at Shropshire Council and that comments were not being directly uploaded onto the planning portal. Mr Smith then read a statement from Mrs Baldwin who raised points about lack of amenity, lack of parking, lack of privacy due to overcrowding as three properties were directly affected, lobby wall deemed to be a party wall and would be 11 feet to the eaves, also concerns about access especially as the communal area is noted in their deeds to be shared by all properties and the lobby is proposed to be built on this. Mr Smith then listed various errors and omissions on the planning application.
